Steinar Strøm er professor emeritus ved universitetene i Oslo og Torino, Italia. Hans hovedarbeids-felt er anvendte økonometriske studier av ulike mikroøkonomiske problemstillinger knyttet til arbeidsmarked, næringsøkonomi, energi- og miljøøkonomi. Han har deltatt i flere transportøkonomiske utredninger som evaluering av Gardermoen-prosjektet og høyhastighetstog i Norge. I det siste har han arbeidet med anslag på skattekostnad og er nå i dialog med Finansdepartementet om utarbeiding av nye anslag. Han deltok i oppstarten av Concept-programmet og deltok i den forbindelse med utformingen av kvalitetssikringsopplegg. Han har vært kvalitetssikrer i flere av Vistas prosjekter.
